## **Couples Trip Participation Requirements**

Unfortunately, there are limited seats available for the couples trip. As a result, Aish Minnesota is only able to accept the number of participants that fill a single coach touring bus. This is approximately twenty (20) couples.

Selection for participation in the couples' trip shall be based on a modified "first-come, first-served" basis. This means that those who register first will be given priority placement for attendance. The modification is that priority placement will be given to couples of which at least one of the members has participated in a past JWRP women's trip or men's trip. In addition, the Aish Minnesota Board of Directors reserves the right to approve, in its discretion, participation by couples in which neither member of the couple has participated in a past JWRP trip. Notwithstanding the foregoing, each applicant understands and agrees that Aish Minnesota, by and through its couples trip committee, board of directors, and it executive committee, has the ultimate right to approve, in its sole and absolute discretion, the selection of any applicant for participation in the couples trip.

This trip is for couples. This means two people that are married, engaged or otherwise romantically paired.

In order to participate, each member must certify at registration that they will arrive in Israel and be at the Orchid Hotel in Tel Aviv by 8:00 p.m. (20:00 in Israel time) on February 18, 2019. This will give sufficient time to arrive at hotel and participate in the Welcome Dinner.

Each couple will need to submit their final travel itineraries to Aish Minnesota at least thirty (30) days prior to commencement of the trip. This is so that Go Inspire may help monitor delays in arrival and facilitate group shuttles from the airport to the Orchid Hotel in Tel Aviv and from our final banquet to the airport.

There will be ample free time on the trip for participants to visit relatives and friends in Israel or to explore Israel on their own. Absent extenuating circumstances (e.g., illness), it is a requirement for each trip participant to attend all scheduled group activities.

Most importantly, though, it is required that each couple make the most of this trip for themselves and for their families by having an incredible time and creating lasting memories.

Aish Minnesota shall not be liable or responsible for any loss or damage which you may sustain to your person or property, or for any loss or damage by reason of any delay, modification, curtailment or arrangement pertaining to the services or facilities furnished on the Aish Minnesota Couples Trip (the "Tour"). You acknowledge that Tour activities, including, but not limited to, hiking, swimming, bus, jeep and air travel, may be subject to certain hazards; and further that you are

voluntarily participating in the Tour and these activities, and understand the dangers and risks involved. You hereby agree to accept any and all risks associated with participating in the Tour. You acknowledge that Aish Minnesota is not responsible for securing your personal property during the Tour or while you are in transit, and is not liable for any loss incurred by theft.

You have consulted or will consult a physician of your own choice and have been or will be advised by said physician that you are in good health, do not suffer from any physical or mental ailment or disability which requires any medical or surgical care or treatment, or which would make your travel and/or participation on the Tour hazardous, unwise, unwarranted or a potential source of danger to you or to others who may travel with or participate on the Tour.
